**Memorandum of Understanding (MoU)
Imam Reza International University,
AND
Manipal International University, Melaka
FOR THE DEVELOPMENT OF ACADEMIC COOPERATION
IN INTERNATIONAL EDUCATION**

The general objective of this Memorandum of Understanding (MoU) is to stimulate and facilitate the Development of collaborative and mutually beneficial programs that serve to enhance the intellectual life and Cultural development on Imam Reza International University represented by Morteza Rojuee and Manipal International University represented by bharath vasudevan and to contribution to increased international cooperation. In addition, the future exchanges in holding double degree online or verbal courses especially in Medical, Engineering, management, MBA, Architecture and art and physical education must be considered. The two Educational Institutions will:

1- Forms of MoU

- a) Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests;
- b) Promote appropriate joint research projects and joint courses of study, with particular emphasis on internationally funded projects;
- c) Endeavor to encourage students and staff to spend periods of time in the host University. The exchange of students will be dependent on the execution of a formal Student Exchange Agreement prior to commencement of this activity
- d) Conduct short courses, as mutually agreed in writing between the parties prior to commencement of this activity
- e) Conduct cultural projects, a, mutually agreed in writing between the parties prior to commencement of this activity
- f) Conduct study tours, a, mutually agreed in writing between the parties prior to commencement of this activity



G) Conduct technological projects, a, mutually agreed in writing between the parties prior to commencement of this activity

2. Terms and conditions

Facilitate the exchange of undergraduate students. Such exchanges may take place for a period normally of one academic year (or at least one term or semester). The academic standing of such students shall be determined by the host University. Exchange students will be accorded the rights and privileges of students in the host country in accordance with the regulations of it relating to students and will be admitted under the terms and conditions relevant to the host University. Accreditation for the academic work carried out by an undergraduate student during the period of study at the host University will be at the discretion of the student's home university

3. Goal of MoU

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective Contributions and benefits of the collaboration, and this shall be subject to periodic review by both Universities.

4. Assistance and support

Academic members of staff and other personnel of one partner institution may spend periods not normally exceeding one academic year in the other partner institution. In supporting such an arrangement. The home institution undertakes to continue the salary of the participant. All other financial matters, including travel costs, are subject to individual negotiation, and will normally be the responsibility of the persons involved and their home institution.

5. Executive protocols

In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.
